Dear Mr. Ellis:

The Clarksville MPO is making an adjustment to TIP project #41 in the FY2008-2011 TIP. The adjustment is to increase the total amount of funds for FY2008 from \$100,000.00 to \$9,520,000.00. Also there is an adjustment made to TIP project #43 in the FY2008-2011 TIP. The adjustment is to increase the total amount of funds for FY2008 from \$100,000.00 to \$1,240,000.00. The MPO has determined that the adjustments to these projects will result in the TIP remaining fiscally constrained.

These adjustments do not change the most recent conformity determination made on July 28, 2005. Therefore, a new air quality conformity determination is not required under the Transportation Conformity Rule (62 FR 43779, 8/15/1197).

It is therefore the request of the Clarksville Urbanized Area MPO that the TIP adjustments be recorded into the FY2008-2011 TIP and forwarded to the appropriate federal agencies.
